SELF GIVING

First, we need to give ourselves to God as a thankful response to all he has done for us through Christ and then give to support the work of Christ. "Thanks be to God for his indescribable gift!" (2 Corinthians 9.15 ESV)

STRATEGIC GIVING

Nearly a million live on Tyneside. Only a small percentage know that Christ is God's gift to the world. How we need to help people in this region trust in and live for Jesus.

SYSTEMATIC GIVING

"Each ... should set aside a sum of money in keeping with his income" (1 Corinthians 16.2 ESV). The Bible speaks of 10% - a tithe; the poor widow gave 100%.

SATISFYING GIVING

It is a privilege to give for the Gospel; and the work in Newcastle needs our joyful support. "Each one must give as he has decided in his heart, not reluctantly or under compulsion, for God loves a cheerful giver. And God is able to make all grace abound to you, so that having all sufficiency in all things at all times, you may abound in every good work." (2 Corinthians 9:7-8 NIV)



GIVING TO GOD'S WORK

In 2019 our faith targets are £925,000 from Jesmond Parish Church and £275,000 from St Joseph's Benwell, to meet our need for £1,200,000 to do the work God is calling us to do across our two churches.

To achieve this requires

OUR PRAYERS AND REALISTIC GIVING.

We have no subsidies. The giving of each one of us is vital.

We suggest giving to The Jesmond Trust (a registered charity), which funds most of the staff and much of our ministry. (The smaller PCC account is for ordinary Jesmond Parish Church costs).

The Jesmond Trust also enables our giving to support World Mission. If you wish, you can give to the range of Christian workers and organisations at home and abroad supported by the Jesmond Trust through the Giving Scheme. For more details of the causes we support, see our separate 'Serving the World' leaflet.

HOW TO GIVE

1. First work out the amount you wish to give – 10% of income is the scriptural minimum. Once you have decided how much to give you need to decide how you would like us to spend it: our suggestion is to give half to the work of our church and half to world mission. If our giving can be planned and regular, that is a great help to our churches.

2. Then decide how to give:

- a.** You can setup a one-off or regular bank transfer using your online banking website or telephone banking system. Our bank details are below.
- b.** You can setup a regular standing order using the Standing Order Form in this booklet.
- c.** You can give by cheque (payable to the ‘The Jesmond Trust’) or cash. We can supply you with a series of envelopes for your gifts if you require.

3. If you are a taxpayer see the relevant section regarding Gift Aid (p6). This enables us to reclaim income tax on your giving at no further cost to you. Tax reclaimed in this way is distributed in the same proportions as the rest of your giving. If you are able to gift aid, please fill in the **Gift Aid Declaration** if you have not done so before or if your name /address have changed. You can also download a copy of the form on our website and email us this information.

4. Finally, it is very important that you communicate with our Finance Team so they know how to administer your giving. It also helps us to plan our finances well. You can do this by filling in and returning “The Response” form or simply emailing your reply to finance@church.org.uk. You can change or cancel a Standing Order at any time but, if you do, please let us know. All our giving is confidential.

Unplanned giving using the box at the door is intended for casual visitors only and not for those who consider themselves part of the church family. Envelopes are available for visitors who want to gift aid their giving.

LEGACIES

In planning our legacy we should pray for God’s guidance. We all have different priorities for family, friends and good causes that we might be able to help when we die. You may like to consider including The Jesmond Trust as one of the beneficiaries of your estate when writing your will. The church office can provide information on how to do this.

INFORMATION FOR TAXPAYERS

Under the Gift Aid scheme, if you pay tax in the UK, we can reclaim tax on your giving; currently 25p for every £1 you give in this way. You do not have to commit yourself to any set amount or to give for a fixed period, but:

- You must sign a Gift Aid Declaration, which will cover any donations you make to The Jesmond Trust and
- You must be a UK taxpayer and
- You must give money in a way that can be traced for audit purposes and
- You must pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6 April to 5 April) at least equal to the amount of tax that all charities or Community Amateur Sports Clubs that you donate to will reclaim on your gifts for that tax year.

The essential feature of your Declaration is a request to The Jesmond Trust to claim back basic rate tax on your giving.

Please note:

- If, in the future, your circumstances change and you no longer pay tax on your income and/or capital gains tax equal to the tax that the charity reclaims you must cancel your declaration by informing us.
- The Inland Revenue require your name and address, so it is vital that you give us your full name, and keep us up to date with your correct address to avoid any confusion in the future.
- We will send you an annual summary of your giving and the tax reclaimed, supplying the information you need to complete your tax form. (If you do not require a summary please tick the box on “The Response” form.)

Tax Credit Relief

You may be interested to know that tax credit relief is available when you make Gift Aid donations. The gross amount of your gift (gift given plus gift aid) is deducted from your gross income.

Higher Rate Tax Payers

You continue to get additional relief on the difference between the basic rate (20%) and the higher (40%) rate. This is claimed through your tax return. In addition, it is possible to claim higher rate tax relief against Capital Gains Tax liability as well as Income Tax.


